## INTRODUCTION TO THE HPC-CERTIFIED ACO PROFILES

In 2017, the Massachusetts Health Policy Commission (HPC) launched a first-in-the-nation set of statewide standards for accountable care organizations (ACOs). An ACO is a group of health care providers that contracts with a payer or payers and assumes responsibility for the quality, outcomes, and cost of care for an attributed population.

At the end of 2023, the HPC certified 14 ACOs, which comprise the first cohort to be re-certified under the HPC's Learning, Equity and Patient-Centeredness (LEAP) criteria, which were first implemented in 2021 and recognize the ACO model as a catalyst for learning and improvement among health care organizations.

To be certified by the HPC for a term of two years, ACOs are required to demonstrate certain core attributes, including that the ACO:

- Collects and uses information from patients to deliver and improve patient-centered care;
- Fosters a culture of continuous improvement, innovation, and learning to improve the patient experience and value of care delivery;
- Uses the best available data and evidence to guide and support improved clinical decision-making;
- Develops, implements, and refines programs and care delivery innovations to coordinate care, manage health conditions, and improve the health of its patient population;
- Seeks to integrate behavioral health and health-related social supports into its care delivery models; and
- Takes steps to deploy data, engage patients experiencing health inequities, and make strategic commitments to improve health equity for its patient population.

This collection of profiles includes information on the 14 HPC-certified ACOs. The profiles provide a snapshot of each HPC-certified ACO, using non-confidential information submitted to the HPC through ACO Certification and other public data, including data from the Massachusetts Registration of Provider Organizations (RPO) program. These profiles are part of a series of policy briefs and other resources that the HPC has created since 2017 to provide policymakers, health care providers, payers, purchasers, researchers, and other members of the public with information and insights regarding the characteristics of HPC-certified ACOs. The primary data sources for the profiles are non-confidential data from the ACO Certification Program applications, publicly available Medicare data, publicly available MassHealth data, and the 2022 HPC RPO program filings. In cases where data pertain to the corporate parent of an HPC-certified ACO, the data about the corporation are framed in a blue box; ACO-specific information is framed in an orange box. 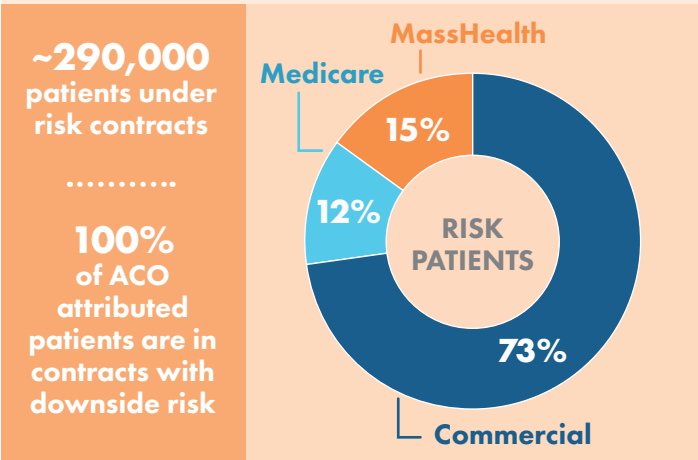

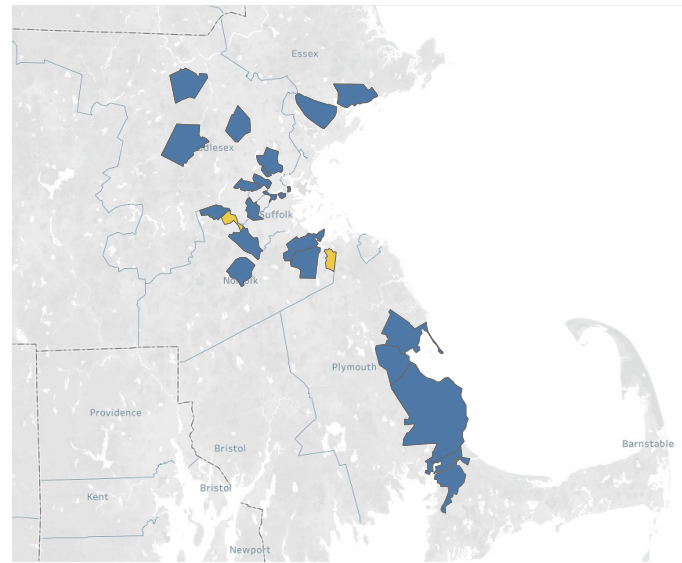

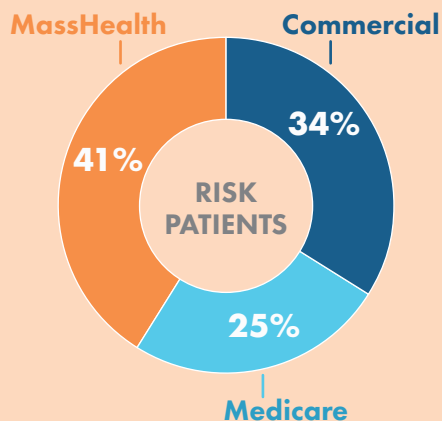

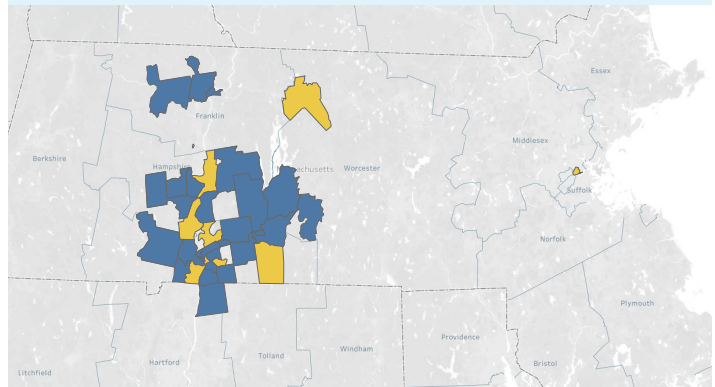

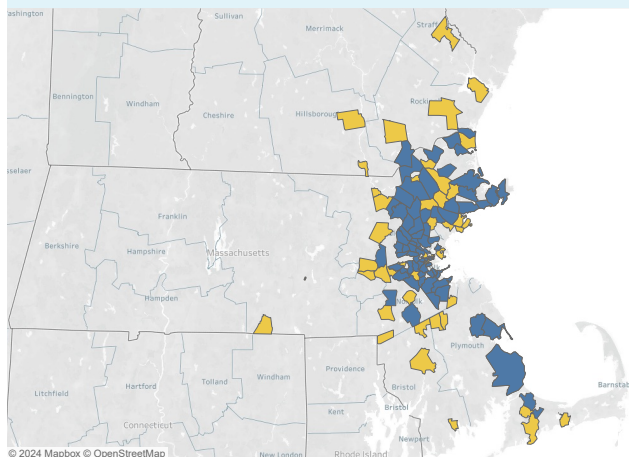

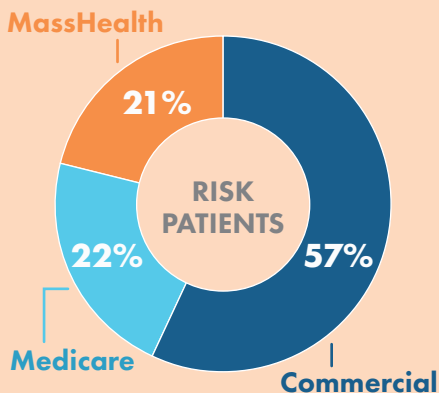

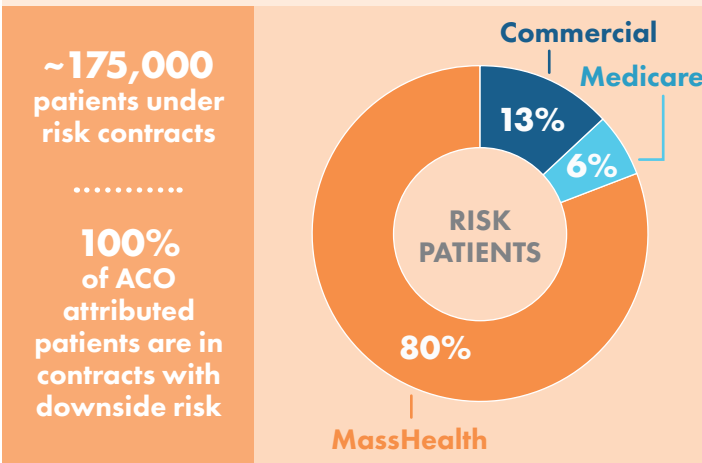

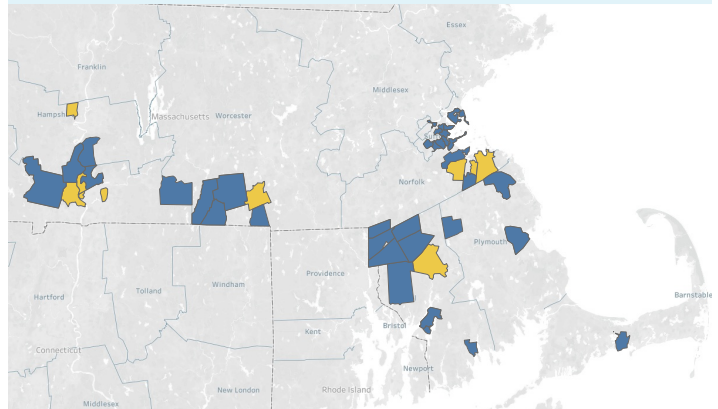

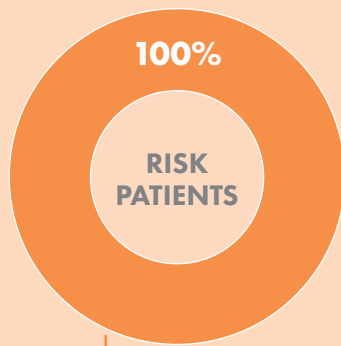

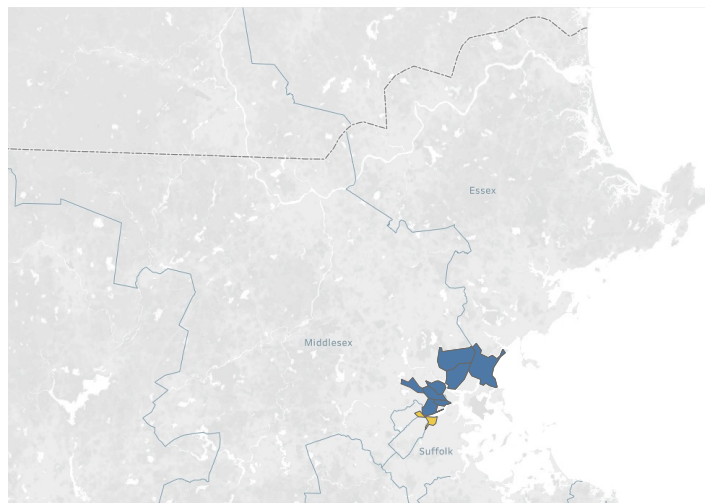

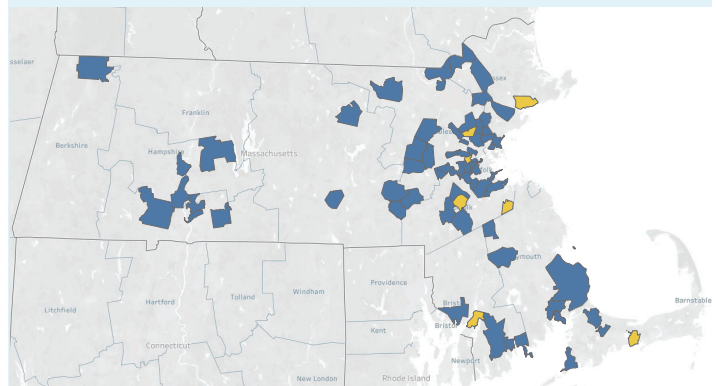

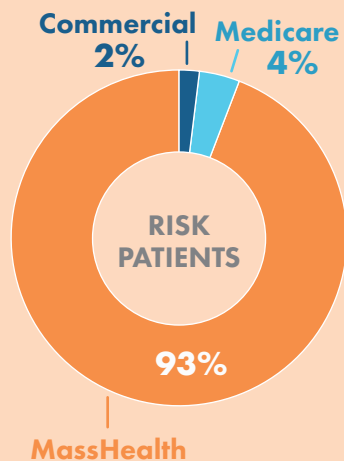

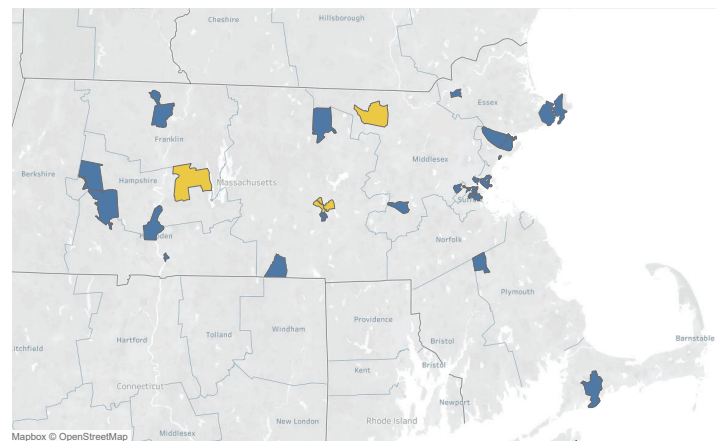

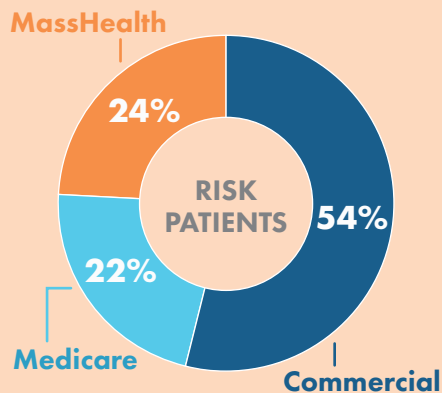

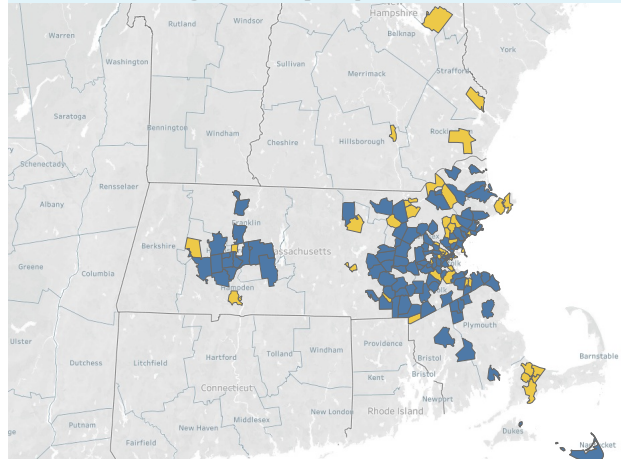

**Location of Physicians Contracting with Reliant Medical Group, by zip code**

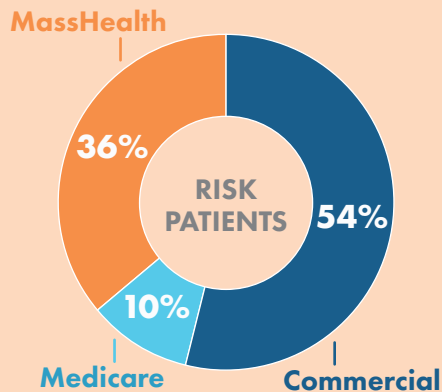

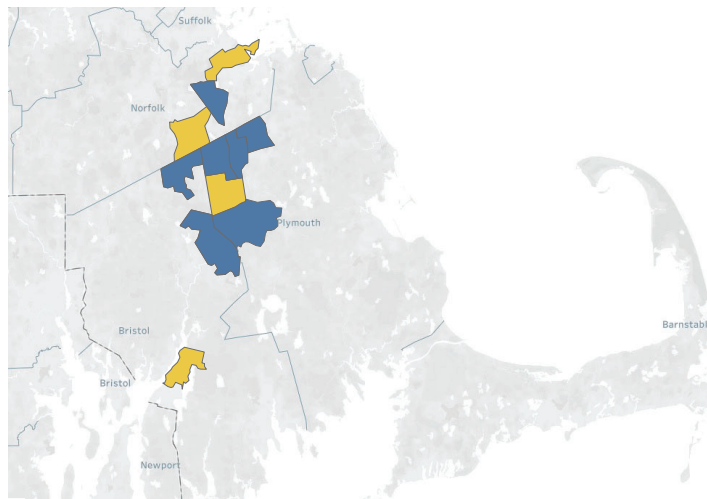

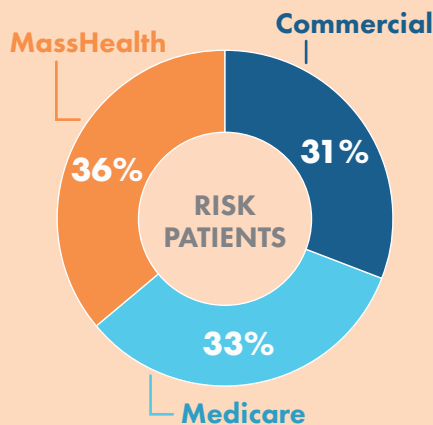

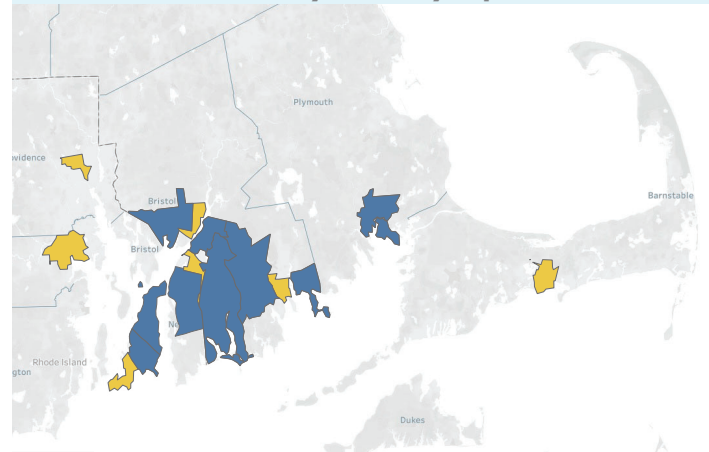

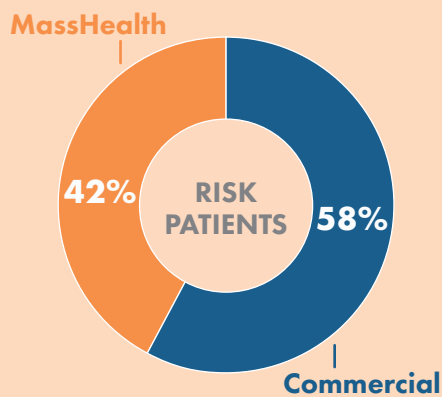

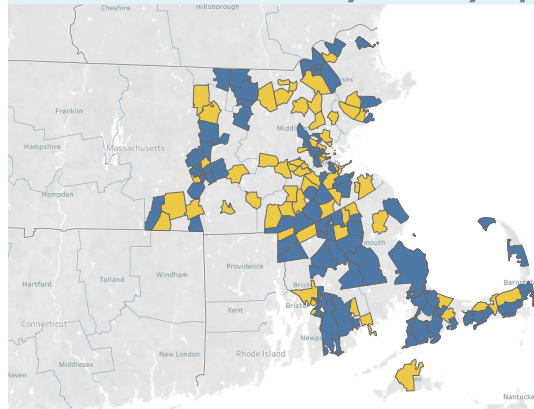

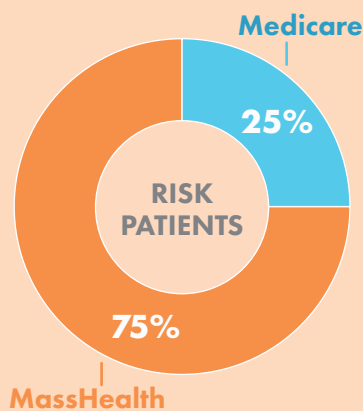

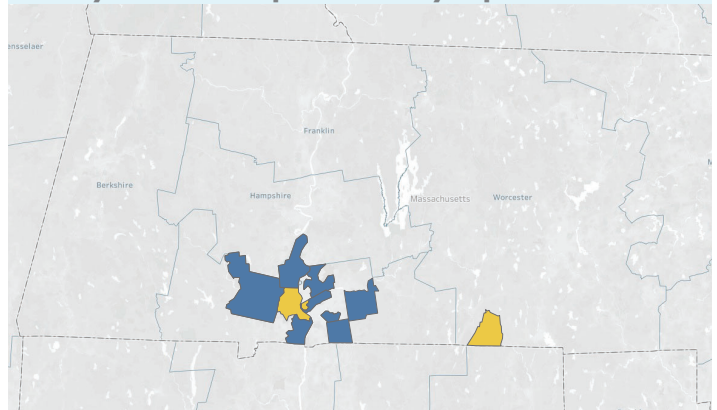

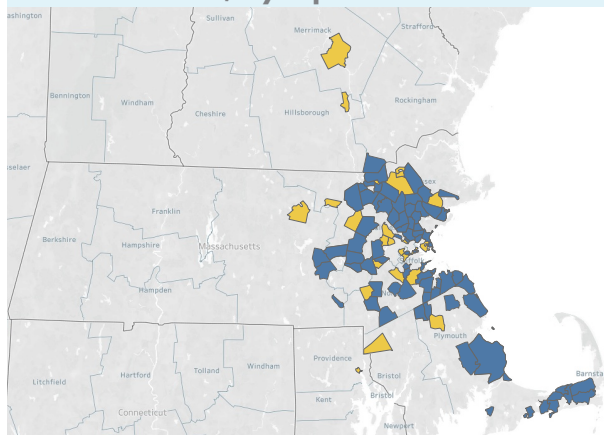

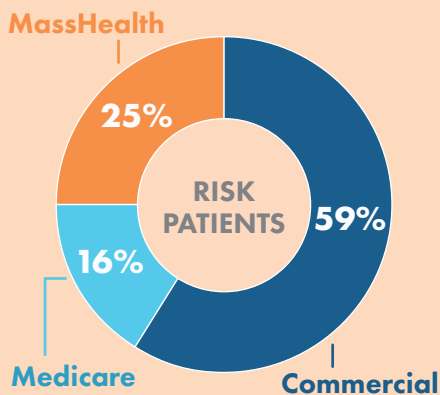

# DATA SOURCES AND METHODS

## HPC-CERTIFIED ACO PROFILES



### Description

The HPC drafted the description using a standard format: “[Certified ACO X] is an HPC-certified ACO, inclusive of [Component ACO A and Component ACO B]. [HPC-certified ACO X]’s corporate parent is [Health System Y], a [non- or for-profit status] organization providing care primarily in [region of Massachusetts, or across the Commonwealth].” In this context, “corporate parent” is defined as the Registered Provider Organization that has ownership or control of the HPC-certified ACO. Information regarding the corporate ownership of an ACO was sourced from the Corporate Organizational Chart RPO attachment and data element RPO-43, Legal Name of Corporate Affiliate. Tax status was sourced from RPO-32, Tax-Exempt Status.

### Organizational Chart

In cases where an HPC-certified ACO has at least one Component ACO, the ACO Profile includes an abbreviated organizational chart showing the relationship between the HPC-certified ACO, the other Component(s), and any corporate parent that is a Registered Provider Organization and has ownership or control of the HPC-certified ACO. These charts are extracts of those submitted to the HPC as part of the ACO certification process.

### ACO Risk Contracts

*Commercial contract data:* The names of the payers with which the ACOs have risk contracts (current as of the date of certification) were sourced from the ACO Certification Program applications.



*MassHealth contract data:* MassHealth has two types of ACOs: Model A (Accountable Care Partnership Plan) and Model B (Primary Care ACO). Information on the model and, where applicable, payer partner was informed by public data sources including the [Full List of MassHealth ACOs and MCOs](#).

*Medicare contract data:* Information on Medicare ACO participation was sourced from ACO Certification Program applications and is current as of the time of application in the fourth quarter of CY2023. Some of the HPC-certified ACOs also hold Medicare Advantage risk contracts; those contracts were not included in the profiles.

Note that all information in the Risk Contracts box pertains only to each ACO's risk contracts and may not be reflective of the corporate parent's entire book-of-business.

## **ACO Type**

Each HPC-certified ACO is classified into one of three categories: academic or teaching hospital-anchored, community hospital-anchored, or physician organization-anchored. This classification scheme builds on the hospital categories employed by the [Center for Health Information and Analysis \(CHIA\) in its FY 2020 Massachusetts Hospital Profiles Technical Appendix](#). ACOs that include at least one academic medical center (AMC) or teaching hospital were classified as academic or teaching hospital-anchored. ACOs with at least one community hospital and no AMC or teaching hospital were categorized as community hospital-anchored. ACOs with no hospital participant were classified as physician organization-anchored ACOs. Note that ACOs classified as academic or teaching hospital-anchored may also contain community hospitals in their systems.

## **ACO Patients**

The figure shown for ACO patients is an approximate sum of the number of patients in ACO risk contracts as reported to the HPC in the 2023 ACO Certification Program applications (excluding any reported Medicare Advantage, Senior Care Options, or Program of All-inclusive Care for the Elderly risk contract lives). These counts represent point-in-time attribution figures at the time of application for certification. It should be noted that some ACOs may be designed to serve only a subset of the population (e.g., pediatric patients only).

## **ACO Risk Payer Mix**

Each profile indicates the proportion of ACO patients that is attributed under Commercial, Medicare, and MassHealth risk contracts (excluding any reported Medicare Advantage, Senior Care Options, or Program of All-inclusive Care for the Elderly risk contract patients). Figures may not sum to 100 percent due to rounding.

## **ACO Downside Risk**

Each profile indicates the percentage of ACO attributed patients in risk contracts that includes both upside and downside risk, as reported to the HPC in 2023 ACO Certification Program applications (excluding any reported Medicare Advantage, Senior Care Options, or Program of All-inclusive Care for the Elderly risk contract patients).

## **ACO Contact Information**

The individual contact information given is for the Applicant Contact, provided to the HPC in the ACO Certification Program applications as the primary public contact for ACO-related matters.

## Quality Performance Information

The HPC has added a section to each profile that includes links to websites where some publicly-reported quality performance data are available, either for the ACO or for the ACO's parent organization. These sources are:

- CHIA's "A Focus on Provider Quality: Selected Clinical Measures, 2018 and 2020," which offers information on HEDIS measure performance for commercial patients;\*
- MassHealth's 2022 Managed Care Plan Quality Performance report; and
- Data.cms.gov, which provides ACO-specific performance information on selected measures for Medicare ACO programs.

## Map

Each profile includes a map showing the zip codes of the practicing providers listed in the MA-RPO Physician Roster file most recently submitted from the date of certification (generally 2022), as given by RPO-108 Primary Site of Practice Zip Code. When noted, not all of the providers identified in this map or in the physician count (see below) may participate in the certified ACO's risk contracts. In cases where only primary care providers (PCPs) or both PCPs and specialists practice in a given zip code, the geographic area of that zip code is colored blue. Where a given zip code has only specialists and no PCPs associated with the RPO, the zip code is colored yellow. Physicians who were classified in the MA-RPO data as both PCPs and specialists were considered PCPs for purposes of the mapping.

## Physician Counts

Physician counts were calculated using Physician Roster data elements RPO-93 Physician NPI, RPO-94 Physician Specialty, RPO-96 Primary Care Provider Status, and RPO-97 Pediatrician Status. Duplicate physician listings were removed prior to generating counts, and PCP, Pediatrician, and Specialty statuses were modified as needed to capture discrepancies between duplicate entries. The individual physician count elements were calculated as follows:

- Total Physicians is the sum of all physicians, after removing duplicates, listed in each RPO's 2022 RPO Physician Roster.
- Total Primary Care Providers is the sum of all physicians, after removing duplicates, listed in RPO-96 Primary Care Provider Status as a "Primary Care Provider," or "Both."
- Total Pediatricians is the sum of all physicians, after removing duplicates, listed in RPO-97 Pediatrician Status as "Yes." This number includes specialists and PCPs.
- Total Specialists is the sum of all physicians, after removing duplicates, listed in RPO-96 Primary Care Provider Status as a "Specialist" or "Both."
- Behavioral Health Physicians is the sum of all physicians, after removing duplicates, who specialize in a behavioral health field such as Psychiatry or Addiction Medicine, per RPO-94 Physician Specialty.

The physician counts are approximate and rounded to the nearest 10, except for counts less than 10. As noted, because a physician may have more than one specialty, the sum of the counts in the individual specialty categories may be greater than the number of Total Physicians listed.

\* Note that in CHIA's interactive online graphic, quality results are shown by medical group. Results at the Parent Provider Group level are available for the following networks associated with Certified ACOs or their parent organizations: Atrius, Baycare, Beth Israel Deaconess Care Organization (BIDCO) and Lahey, New England Quality Care Alliance (Tufts Medicine), Partners (now Mass General Brigham), and Steward.
