Office of Health Resource Planning

Overview

The Office of Health Resource Planning (OHRP) was established with the goal of identifying and addressing service gaps and challenges in the Massachusetts health care system while fostering patient-centered care.

As the entity leading the first Massachusetts state health planning effort in over a decade, the OHRP applies rigorous data collection and analytic techniques to evaluate health care resource access and needs. OHRP investigates and reports on the factors that drive the misalignment of supply and need and makes policy recommendations to promote the appropriate supply and equitable distribution of services.

The OHRP is responsible for developing a **state health resource plan** to identify existing resources and the anticipated needs of the Commonwealth related to health care services, providers, programs, facilities, and workforce. Among the stated goals of the plan are maintaining and improving the quality of and access to health care services; ensuring a stable and adequate health care workforce; meeting the health care cost growth benchmark; supporting innovative health care delivery and alternative payment models; avoiding unnecessary duplication of health care resources; and advancing health equity and addressing health disparities.

Task Force Legislative Mandate

Pursuant to **Chapter 186 of the Acts of 2024**, the Maternal Health Access and Birthing Patient Safety Task Force shall study:

- Past **essential services closures** for inpatient maternity units and acute-level birthing centers and closures of community-based, office-based, and preventative maternal health care;
- Patient quality and safety considerations of essential service closures of maternal care units; and
- **Demographic information** on patient populations whose access has been most affected by past closures of or current limitations on the availability of maternal care services.

The Task Force is charged with:

- Studying the current availability of and access to maternal health services and maternal health care across regions and patient populations, including the essential service closure process and adequacy of the maternal health care workforce;
- Identifying methods to increase the financial investment in and patient access to maternal health care across Massachusetts and ensuring equitable access for the most vulnerable birthing patient populations; and
- Issuing a report on the Task Force's findings and policy recommendations.

Chapter 2: Massachusetts Maternity Care Supply and Capacity

Chapter 3: Hospital Maternity Unit Closures, 2013 – 2024



- Summary of maternity unit closures in Massachusetts
 - Total number of units and beds closed; location of closures
 - Common factors described in Essential Service Closure filings as justification for closure
- Case study of each maternity unit closure
 - Hospital statistics: CHIA hospital cohort, system affiliation, financial performance, payer mix, relative price, volume
 - Maternity unit statistics: size, volume/occupancy, geographic and demographic communities served, maternal quality measure performance, representativeness of community
 - Circumstances of closure: type of closure (e.g., whole-hospital or unit only), reasons for closure, date
 - Impacts of closure: e.g., drive times, low-risk C-section rates, induction rates, SMM, prenatal care adequacy
 - Key themes observed across closure case studies
 - Patterns in hospital or maternity unit characteristics among hospitals that close
 - Patterns in how closures affect patient outcomes
 - Patterns in where patients go for maternity care after a hospital closure

Chapter 4: Birth Center and Office-Based Care Closures

Birth Center Closures

- Identification of closures, as sources allow
- Literature review and other qualitative insights on financial and regulatory barriers that birth centers face

Office-based Care Closures

- Identification of closures, as sources allow
- Changes in OB/GYN headcounts in outpatient settings over time



Chapter 5: Policy Recommendations



Possible areas for recommendations, depending on findings:

- Tracking hospitals at risk of closure; preventing closures of hospitals that are important based on drive times, quality, access, and affordability
- Regional planning to centralize care and prevent multiple closures in an area
- Mitigating harms of closures, including through transition planning
- Additional authorities needed related to closure
- Workforce supports
- Reimbursement/financial reforms
- Areas for further research

Maternal Health Access and Birthing Patient Safety Task Force

Overview

In August 2024, Governor Maura Healey signed **Chapter 186 of the Acts of 2024**. An Act promoting access to midwifery care and out-of-hospital birth options. Section 48 establishes a new nine-member task force on maternal health access and birthing patient safety in the Commonwealth which is co-chaired by the Massachusetts Health Policy Commission and the Massachusetts Department of Public Health.



The task force is charged with studying and reporting on maternal health access and birthing patient safety across Massachusetts, including the current availability of maternal health services, financial investment in maternal health care, and the impact of past essential services closures.
